CHILI BOOTH APPLICATION AND OFFICIAL RULES

1. Contestants check-in/register at Elk Grove Park starting at 7:00am. No set-up allowed after 9:00am.
2. Cooking of chili will begin after registration. All chili samples for judging will be picked up at 11:00am. Judging of the chili will begin at 11:30am with the winner announced at 3:00pm. Chili booth holders can begin vacating their site beginning at 4:00pm.
3. Contestants are responsible for supplying their own cooking stove (preferably propane). **NO POWER OR WATER WILL BE PROVIDED.**
4. Each contestant will be assigned a number and a pint container. The container will be collected at the time of judging. The decision of the judging shall be final.
5. Contestants must make at least 10 gallons of chili to allow for judging and chili kit tasting.
6. All ingredients **MUST** be assembled and cooked on-site, due to health considerations.
7. Meat may be precooked, and vegetables pre-cut. No clean-up will be available on-site.
8. Chili kits (Spoons, bowls, and napkins) provided by the End of Watch Fund.
9. Chili cooking only – no sales allowed from booths.
10. Amateurs only – no professional cooks.
11. Due to insurance requirements, no personal alcoholic beverages
